Rethinking land and building use flexibility

As Hong Kong continues to look for developable land across the New Territories and through urban redevelopment, allowing for certain flexibilities in land-use and building plans can help cope with unforeseen changes and provide room for development. On this assumption, balancing legal certainty and land-use flexibility can help narrow potential mismatches between planned land and building uses and future economy.

The current regulatory regime makes planning, development and redevelopment a long and sometimes drawn-out process. Room for alternative activities is also limited. Costs and compliance issues are other factors to consider when designing flexible, adaptive buildings.

Streamlining vetting and approval procedures

Under the existing regulatory framework, planning, development and building activities are overseen by the Planning Department (PlanD), Lands Department (LandsD), and Buildings Department (BD). This regulatory framework aims to ensure the community's health, safety, convenience, and general welfare by guiding and controlling land development and use.

It is, therefore, inevitable that it takes a long time to file applications to these regulatory bodies one by one, each operating on different standards and criteria, says Sr Terence Wai, Chairman of the HKIS Planning and Development (PDD) Division. To expedite the urban redevelopment process, he suggests that the Government review and streamline the current development plan vetting process.

The possibilities of setting up a centralised approval mechanism or authority for development plan vetting and approval should be explored, he advocates. Such a mechanism can ensure that all concerned government departments are consulted and that their feedback can be collected and actioned in one go.

Wai also suggests that standards and requirements, such as gross floor area, site coverage and building height, be standardised across the three regulatory bodies so that they can implement the vetting and approval procedures concurrently.

According to the Development Bureau, a Steering Group on Streamlining Development Control was established in 2018 to find ways to unify and streamline various approval standards and streamline the approval process.

"While the public's opinion towards a development plan should be respected and taken into consideration, we suggest that the TPB organise consultation meetings with district councils and community stakeholders more frequently and efficiently," he says.

Wai suggests that plot ratios for larger residential redevelopment sites be relaxed to encourage urban redevelopment activities. This way, developers would find it more economically viable to acquire adjoining sites and pursue a higher development density.

Expediting industrial building redevelopment

In 2010, the Government lowered the collective sale threshold to 80 per cent for industrial buildings older than 30 years old pursuing redevelopment. In 2018, it introduced more incentives, including relaxing the maximum plot ratio by up to 20 per cent to incentivise private owners to develop ageing industrial buildings. The latest initiative to expedite industrial building redevelopment is the pilot scheme to charge standard rate premiums for lease modifications.

Currently, for an application for converting an industrial building within an industrial zone into pure office and commercial uses, or on the upper floors of an I-O building (other than those specified in Column 1 of the Notes), planning permission from the TPB is required.

Sr Jason Kwong, Council Member of the HKIS General Practice Division (GPD) applauds the Government's efforts in promoting industrial building redevelopment and revitalisation. Echoing what Wai says, however, he argues that going through the TPB is a time-consuming process, not to mention the procedures required by the other regulatory bodies.

Wai adds that many industrial buildings are closer to residential and commercial zones, ideal for redevelopment or wholesale conversion into other uses. But due to their ownership structure, it requires the consent of the majority of owners (i.e., at least 80 per cent of undivided shares) to agree on a collective sale for redevelopment or wholesale conversion.

"I would suggest that the Urban Renewal Authority (URA) take the lead in the negotiation of buyout terms with individual owners and collaborate with private developers on industrial building redevelopment projects, like the way it carries out residential redevelopment," says Wai.

More flexible codes for mixeduse developments

Citing a consultation paper in 2003, Kwong says the PlanD has proposed a type of zoning known as OU(mixed-use), which would provide more flexibility for the development of mixed-use buildings. It is believed that such mixed-use developments would create more vitality, encourage diversity of uses, and allow for greater flexibility to adapt to changing market needs.

Accordingly, OU(mixed-use) would allow developers to avoid the rigidity of the R(A) zone, which results in a maximum of three non-domestic storeys beneath pencil-like residential towers. Meanwhile, the Notes for the OU(mixed-use) zoning could be specified in such a way as to minimise any interface problems between domestic and non-domestic uses within the same building, he says. OU(mixed-use) zoning could be found in some new development areas.

"Under this zoning, the developer would be able to decide the proportion of the residential floors relative to the office and retail floors within the same complex. The prerequisite is that nuisances to and potential conflicts of uses with the residential floor occupants should be minimised using separate entrances and lift lobbies," says Kwong. "The K11 project at Hanoi Road, Tsim Sha Tsui is a good example of a mixed-use building in terms of value creation."

Integrating adaptability into modular construction?

Modular integrated construction (MiC) is gaining popularity as a more sustainable, cost-effective approach to property development. In the west, there are advocates for using MiC to extend the lifespan of a building. This can be achieved by designing building modules and structures that can be reconfigured or expanded to fit the changing requirements of the occupiers.

However, while prefabricated modules could be designed to serve multiple purposes in theory, the cost of doing so could be prohibitive in practice, says Sr Arthur Cheung, Chairman of the HKIS Building Surveying Division (BSD).

"There are different sets of fire safety and structural requirements, such as fire-resisting construction and imposed loads, governing residential, commercial and industrial buildings, for instance. If one prefab module is designed to be flexible enough to serve multiple purposes, the cost would be prohibitive, unless there's a clear government policy in place that supports the industry to use MiC to achieve adaptable building design."

In 2019, the LandsD began to grant industrial building owners a waiver for converting existing industrial buildings en bloc, or part of it, into transitional housing for a term of not more than five years. These buildings must be in areas zoned as 'Commercial', 'Comprehensive Development Area' and other 'Other Specified Uses' annotated 'Business' or 'Residential'.

"This is a well-intended initiative to provide more transitional housing for the less advantaged families currently waiting for public housing. But converting industrial units into residential flats is technically challenging," explains Cheung.

"For a flat to comply with the building ordinance, certain lighting and ventilation requirements have to be fulfilled. But given the large floor plates of industrial buildings, when an industrial unit is subdivided into multiple flats, the flats in the middle cannot afford enough natural light and ventilation. They so cannot comply with the existing building regulations."

Challenges in managing mixeduse buildings

Sr Ray Ng, Council Member of the HKIS Property and Facility Management Division (PFMD), says managing mixed-use or older composite buildings requires the Owners' Corporation (OC) to have good communication with all owners and tenants. "On behalf of the OC, the property manager plays a facilitative role to ensure that the unit usage restrictions stipulated in the Deed of Mutual Covenant (DMC) and house rules are observed," he says.

Many older composite buildings are now occupied by a diverse mix of tenants of different trades. Their activities in their units are legally disputable. Even if the use meets legal or specific licensing requirements, the property manager would also suggest preventive or mitigation measures to minimise potential disturbances and nuisances caused by specific tenants to others.

For example, in a building where clinics coexist with other general tenants, in addition to strengthening the cleaning and disinfection of public areas and facilities, the property manager may propose dedicating a lift exclusive to serving the clinics' visitors for reducing the risk of disease transmission. For landlords renting

out industrial spaces to band rooms or rehearsal studios, acoustic insulation should be fitted as part of the provision.

Apart from minimising nuisances caused by particular tenants, Ng says the property manager also plays an important monitoring and coordinating role in ensuring that tenants comply with building safety standards.

"When a unit is undergoing renovation, we would pay attention to whether load-bearing and fire compartment walls are damaged and whether the fire escape has been illegally altered. If there are suspected violations of the Buildings Ordinance or Fire Protection regulations, we would gently remind the landlord to make corrections. But for repeated violations or immediate hazards to all owners or the public, we may resort to reporting to the authorities for enforcement actions."

While land-use zoning protects against undesirable outcomes and provides a degree of certainty, sometimes it could be overly rigid and protects the status quo at the expense of future adaptability. As Hong Kong is set to enter a new phase of development as its integration with the Greater Bay Area continues, how land and building uses can be made more adaptable to changing needs, some foreseeable and some unforeseeable, is worth a rethink.



重新思考土地及樓宇用途靈活性

隨著香港繼續透過開發新界土地及市區重建以增加土地供應,在土地用途和項目規劃上預留一定靈活性,有助於應付未來不可預期的變化,提供較大的發展空間。在此假設下,在法律框架與土地用途靈活性之間作出更佳平衡,有助於緩減未來經濟轉型所產生的土地資源錯配問題。

話雖如此,目前的規劃、建築物管制及土地行政 等方面的法規,由不同部門處理審批,制度之間 難免重覆,審批時間需時,對土地及樓宇用途亦 有仔細限制。此外,靈活和適應性較強的建築設 計,涉及額外成本和合規問題,故要提升土地及 樓宇用途的高靈活性,在法律、技術和成本等可 謂困難重重。

簡化審批程序

在現行規管架構下,規劃、建築物管制及土地行政等法規由規劃署、地政總署和屋宇署負責,旨在透過引導和管制土地發展及用途的工作,促進社區的衞生、安全、便利及一般福利,並且為市民締造一個組織更完善、效率更高和更稱心的居住和工作環境。

學會規劃及發展組主席衞振聲測量師表示,在籌劃發展項目時,發展商須先後向上述機構提出申請,而它們各自的審核標準和條件皆有所不同, 過程冗長。因此,為加快市區重建步伐,他建議 政府審視和精簡現行的項目審批程序。 他認為,政府應繼續研究如何統一及理順各項審 批標準,精簡審批流程,例如探討建立中央審批 機制或窗口的可能性。統一處理項目發展申請, 讓申請人可一次過取得所有相關政府部門意見, 盡早採取相應措施以符合法例要求。

他還建議,三間監管機構應統一標準和要求,例 如總建築面積、佔地面積和建築高度等標準,以 便同時執行審查和批准程序。

發展局表示,當局於 2018 年成立「精簡發展管制督導小組」,研究如何統一及理順各項審批標準,力求精簡審批流程。

「當然,公眾對地區發展項目的意見應予以尊重, 但我亦希望城規會能提升與區議會和社區人士諮 詢會議的效率,縮短諮詢時間。」他說。

為了鼓勵市區重建,衞振聲測量師建議放寬市區 呎數較大的住宅重建地盤的地積比,相信能鼓勵 發展商更積極收購舊樓,拼合出佔地較大的重建 地盤,以獲取更高發展密度,從而提升項目發展 經濟效益。

加快舊工廈重建

2010 年,政府將樓齡超過 30 年有意出售用作重建用途的舊工廈,強拍門檻由 90% 降低至 80%。 2018 年,當局新增工廈重建鼓勵措施,包括放寬

最高核准非住用地積比率,上限為 20%。近月更推出工廈重建「標準金額」補地價先導計,加快工廈重建的修契程序,推動活化工廈。

目前而言,如要申請將工業區內的工廈(或私人工貿大廈(I/O)高層)改成純寫字樓和商業用途(《註釋》第一欄規定除外),則需要取得城規會規劃許可。

學會產業測量組理事鄺偉賢測量師樂見政府近年 積極推動工廈重建活化,然而,他認同衛振聲測 量師的看法,指出城規審批程序過長,有需要精 簡審批。

衞振聲測量師補充説,有不少工廈較鄰近住宅和 商業區,非常適合重建或改裝成其他用途。但由 於這些工廈業權分散,需要集齊80%業權份數的 業主同意才可聯售進行重建或整幢改裝。

「我會建議由市建局牽頭與工廈業主商討收購條件,並與私人發展商合作重建,做法就如現時市 區住宅重建項目一樣。」

商住混合用涂建築規範

屬偉賢測量師引述 2003 年的規劃署諮詢文件並表示,規劃署提出其他指定用途(混合用途),容許項目以較靈活的混合模式發展,相信能為社區創造更多活力,鼓勵多元化商業活動,以應對不斷變化的市場需求。

據悉,相對於較嚴苛的住宅(甲類)用途,其他指定用途(混合用途)允許發展商多元化規劃項目,避免形成建於三層商場的「牙籤樓」等刻板的建築設計。《註釋》亦訂明,發展商應盡量解決樓宇內住戶與非住戶的接口問題,例如透過設立住戶專用大堂及升降機,確保住戶私隱和安全。部分新發展區亦設有其他指定用途(混合用途)的用途地帶。

「在這用途下,發展商可靈活決定分層住宅、寫

以組裝合成建築法提升項目未來的適應性,可行嗎?

組裝合成建築法(MiC)作為一種更可持續、更 具成本效益的建築方法,在業界越來越受歡迎。 西方業界更有人提倡設計出有利於日後改變用途 及重用的 MiC 組件,以適應用戶不斷變化的需求。

不過,學會建築測量組主席張文滔測量師指出, 雖然理論上預製組件可以容許多種用途,但實際 上成本上並不划算。

他坦言:「住宅、商業和工業樓宇對消防和結構 安全都有不同要求,如耐火結構和承重等。如果 同一件預制組件需要符合不同的安全要求,成本 必然大幅增加,除非有明確的政府扶持措施支持 業界利用 MiC 實現多用途建築設計,否則從成本 效益的角度看來,這個做法難以實行。」

2019 年,地政總署落實給予工廈業主地契豁免,容許位於「商業」、「綜合發展區」和「其他指定用途」並註明「商業」或「住宅」地帶的工廈,整幢改裝工廈以提供過渡性房屋單位,為期不超過五年。

「這措施原意很好,希望藉此提供更多過渡性房屋,協助輪候公屋的基層市民。不過,要將工廈單位改裝成住宅單位,在法規和技術上存在不少挑戰。」張文滔測量師解釋說。

「住宅樓要符合建築條例,必須滿足一定的採光 和通風要求。但鑑於工廈單位呎數大,當分間出 幾個住宅單位時,中間的單位較難符合採光和通 風要求。」

管理混合用途樓宇的挑戰

學會物業設施管理組理事吳傑華測量師表示,混合用途或舊式商住(或稱綜合用途)樓宇的業主組織(即法團或委員會),有需要與各單位業主及其租戶保持良好溝通,物業經理則發揮積極的協調角色,確保業主和用戶遵守大廈公契當中的單位使用限制和必須遵守的規則。

現時,許多舊式綜合用途樓宇都有不同類別的租戶,單位用途是否合法存在不少爭議。即使用途 已符合了相關法例或特定牌照要求,物業經理也 會建議採取適切的預防或緩減措施,以盡量減少 某些租戶活動對他人造成的滋擾。

例如,在一些診所與其他一般租戶並存的樓宇,除加強對公眾地方及設施的清潔消毒外,物業經理可建議為診所訪客安排使用指定甚至直達樓層的升降機,以減低疾病傳播風險。而用作 Band 房的工廈單位,亦可建議業主預先安裝隔音降噪設施。

吳傑華測量師續說,除了盡量減少特定類型租戶 有可能造成的滋擾外,物業經理在確保租戶遵守 樓宇安全標準上,也發揮著重要的監察和協調作 用。

「例如,某單位在裝修時,我們會特別注意主力 牆和耐火間隔是否受損,走火通道是否被不合法 改動。如懷疑某租戶違反了建築物條例或防火條 例,我們一般會先提醒業主通知租戶作出糾正, 但對於屢次違規或直接構成公眾安全風險的用 戶,我們有責任向當局報告以採取執法行動。」

明細的土地用途劃分,能一定程度減少土地使用 者之間的矛盾,但過於僵化的用途分類,有可能 削弱發展過程中所需的靈活性和適應性。隨著香 港與大灣區的持續融合,香港將進入一個新的發 展階段,如何令土地和樓宇用途更能適應不斷變 化和不可預見的需求,值得各方重新思考。

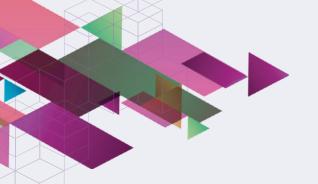

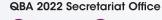

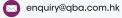

CIM 基础平台标准编制的思考 与建议

近年来,各界已普遍认识到,城市信息模型(City information modeling,以下简称"CIM")基础 平台的提出,可解决智慧城市建设中数据共享和 业务协同的痛点和难点问题,可有效支持智慧城 市建设。自2018年以来,住房和城乡建设部先 后在广州、南京等地区开展 BIM 报建审查和 CIM 基础平台建设的试点工作。与此同时,各地CIM 基础平台建设发展十分迅速,截止到 2021 年 10 月,据不完全统计,共有31个城市105个项目 提出 CIM 基础平台的相关建设愿景,涉及招标金 额总计约为 6.7 亿元,建设内容包括园区、开发 区、新区、城市等不同尺度的CIM基础平台建设、 标准建设以及智能化审批、安全监管等 CIM+ 应 用开发。

CIM 标准编研的背景特点

CIM 基础平台涉及多源数据融合、多业务协同、 多主体参与,这就需要一套完善的标准体系规范 数据接入、平台建设、运维保障等各个环节。标 准的编制一般要以科学、技术和实践经验的综合 为基础。建筑信息模型(简称"BIM")的发展 经历了 20 多年的实践,如今 BIM 标准体系已经 趋于成熟。而 CIM 的发展仅3年时间,在建模 和应用技术上其复杂程度远高于 BIM, 而且我国 CIM 标准的出台有著显著的现实性背景:

一是快速增长的建设需求催生标准迅速出台。在 相关成熟经验还比较缺乏、国家和行业等相关上 位标准还不太完善的背景下,各地结合数字政府、 智慧城市、城市更新等工作纷纷提出 CIM 基础平 台的建设愿景。鉴于 CIM 基础平台建设是一项复 杂性较高、多种技术交融、多主体参与的长期性 工作,项目的落地实施必须有相应的标准来规范 平台建设,催生了标准的迅速出台。

二是三级 CIM 基础平台体系的建成需要标准来保 障。住房和城乡建设部在2020年9月印发的《城 市信息模型 (CIM) 基础平台技术导则》中,提 出要建立国家-省-市三级 CIM 基础平台体系。 当前 CIM 基础平台的建设属于自下而上的探索性 建设阶段,城市仍是 CIM 基础平台建设的主场。 如何保障各城市在探索过程中走出个性的同时具 有一定的共性,能够和省级、国家平台有效衔接, 都急需标准来规范。

三是CIM基础平台实践周期短,可参考案例较少。 CIM 需要多个行业、多个领域、多个管理层级的 横、纵向打通,在国内外均处于探索阶段,已建 成和可参考的成熟案例较少,而且对于CIM的认 识也在处于逐步统一的过程中,国家、行业、地 方、企业各级标准之中也存在著缺位现象。

未来 CIM 标准编研的思考

在以上背景下,笔者认为我国 CIM 标准的出台将 有别于传统行业标准。这是在阶段性经验总结的 基础上,适应实际工作的切实需要,需要不断进 行迭代更新。

首先, CIM 基础平台相关标准将是急用标准优先 出台、逐步完善,形成 CIM 基础平台标准体系的 过程。横向来看,可按 CIM 基础平台的建设内容 分为基础类、数据类、平台类、应用类、运维类、 安全类等标准。纵向来看,可按标准发挥的定位 和功能分为基础类、通用类和专用类标准。从当 前已公开或徵求意见的标准来看,标准是根据平 台建设的紧迫程度按序推出的。在省级或城市的 地方标准中,大多集中于城市级 CIM 基础平台的 数据类或平台运营类标准,以及结合工程建设项 目审批等专项工作推行的信息交付类标准等。在 行业标准中,自2020年9月,住房和城乡建设 部办公厅陆续发布或公开徵求意见的 CIM 相关行 业标准共9项,其中标准类型涉及基础类标准2 项、通用型标准3项、专用类标准4项。从推出 时序来分析,行业标准的出台是快速回应各地建 设平台和数据加工的技术性要求,解决项目实施 落地过程中的难点问题。同时,也是在不断推进 工作中逐步统一认识,共同谱写 CIM 基础平台标

准体系图谱的过程。这一点在最新发布的《城市信息模型应用统一标准(徵求意见稿)》中有所体现,该标准是 CIM 类标准中的基础和纲领性标准,明确了 CIM 表达的对象、模型内容等,为其他标准提供了纲领和框架。

其次,CIM 标准是阶段性成熟的产物,但需要随著技术和实践的发展不断迭代更新。当前发布或正在徵求意见的 CIM 标准,是在对试点成熟经验总结和充分的技术探讨下形成的产物,在当下及较长一段时间对实践会有较大的指导意义。但 CIM 基础平台的建设中既有多源数据的汇聚,也有多种信息技术的集成,同时有多种应用需求的交织。随著信息技术的迭代更新,数据获取和治理技术的不断演替,以及应用探索中需求的不断变化,CIM 基础平台的标准也将是不断修订更新的过程。

结论

总体来看,我国 CIM 基础平台的发展迅速。各地已经普遍认识到 CIM 基础平台建设对智慧城市和城市治理现代化的突出贡献。当前,随著各地项目落地的实际需求和国家对该项工作的总体部署,各城市相关部门、省级管理部门和国家有关部门已经开始编研 CIM 基础平台的数据和平台类标准。未来,随著 CIM 基础平台逐步进入验收和运营阶段,评测类、应用类、安全类的标准需求将更为突出。

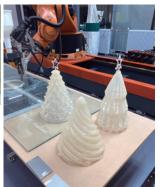

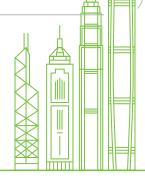

HKIS BIM Conference 2021 Explored challenges and opportunities of digital integration of advanced technology for surveyors

The Hong Kong Institute of Surveyors (HKIS) hosted the HKIS Building Information Modelling (BIM) Conference at the Surveyors Learning Centre on 2 December. Themed "Digital Integration of Advanced Technology for Surveyors: Challenges and Opportunities" the Conference gathered more than 150 participants including government officials, business leaders, industry experts and scholars attending both online and offline to deliberate on the prospects of Development Information Modelling used by the surveying industry. Mr CHAN Tak Yeung, Thomas, Principle **Assistant Secretary (Works) of Development** Bureau of the Hong Kong SAR attended the Conference as its Guest of Honour.

Digitalisation and new work models have pushed the evolution of surveying industry. Coupled with the Government's commitment of building a northern metropolis put forward in its latest policy address, Hong Kong will see a substantial increment in land development and construction. Facilitating such government strategy will not only require extensive adoption of Building Information Modelling (BIM) by the surveying industry as well as the property development and construction industry, but will also need comprehensive knowledge of a broader concept brought up at the Conference - the Development Information Modelling (DIM), and an enhancement in the application of digitalisation and information to cater for a new environment and new requirements. With the aim of inspiring participating professionals to explore more possibilities, six industry leaders and experts were invited to the Conference to share and discuss in detail the onward trends and potentials of digital technology.

The Guest of Honour of the Conference, Mr CHAN Tak Yeung, Thomas, Principal Assistant Secretary (Works), Development Bureau of the Hong Kong SAR shared that "BIM has in fact become the backbone of our design and construction works and is a linchpin of all our digital construction initiatives such as Modular integrated Construction (MiC), Multitrade integrated MEP (MiMEP), etc., which all rely on the accuracy of the data of BIM models for automated and computerised fabrication of the construction modules in a safe and cost effective manner.

In his welcome remarks, **Sr Edwin TANG**, **President of the Hong Kong Institute of Surveyors (2020-21)** mentioned, "Unlike previous editions of the BIM Conference, this year we have explored a number of related advanced technologies commonly used by the construction industry such as big data and cloud platform. We hope that the Conference has inspired industry professionals to make use of these tools to speed up digital transformation and step up themselves for a new digital era."

Sr YIP Yin-yung, Chairman, HKIS Building **Information Modelling Committee** mentioned in his closing remarks, "The Conference has explored how surveying industry can adopt and integrate the use of digital technology from multiple perspectives. I hope that participants can get a comprehensive understanding of the possibilities that digital technology presents, and how we can maximize the speed and efficiency in the development of land, planning and construction despite limited resources. The application of BIM should go beyond construction phase into the entire land and housing development cycle. The novel idea of DIM will help us step outside the current BIM definition."

The HKIS Outstanding Dissertation/Thesis Awards 2020 Executive Summary of Winning Papers

A STUDY ON THE FEED-IN-TARIFF (FIT) SCHEME IN HONG KONG: A REVIEW OF THE COSTS AND BENEFITS OF INSTALLING SOLAR PANELS

Undergraduate Category (PFMD) – Top Award Winner: LUK Sin Yee
The Hong Kong Polytechnic University – BRE

In recent years, Hong Kong has proposed increasing its renewable energy use. Feed-intariff (FiT) is a new initiative for stimulating the development and adoption of renewable energy by providing economic incentives to the private sector. Since FiT's launch two years ago, its practitioners have aimed to encourage more users of and investors in solar energy. FiT can be a great platform for the development of renewable energy in Hong Kong, but its effects and impact are still under-assessed. Thus, this dissertation attempts to investigate and examine the feasibility of FiT and determine if it has the potential to help ensure a sustainable future.

In the course of investigating the feasibility of FiT in Hong Kong, the author conducted literature

reviews, case studies, and questionnaire surveys among potential applicants. Her research revealed that Hong Kong had a very high initial FiT rate in the broad view when compared to its Asian neighbours. In addition, the differences in value between this FiT rate and standard residential tariffs in Hong Kong were the highest in the region, thus creating a financial incentive to adopt FiT. Given Hong Kong's high electricity tariffs, it could take up to six years for a solar PV system in a general village house to be paid off.

Apart from economic issues, the FiT application process is smooth, but often troublesome and time-consuming. Hence, the duration between the application for FiT and the installation of solar panels in the average residential unit takes over half a year. As for learning FiT in schools, it involves a lot of training, so it would be difficult for teachers who lack knowledge of solar-related projects to teach it.

To improve the performance of FiT, power companies can provide more technical help in data submission to simplify the application process. Meanwhile, the Government should provide more support to increase FiT's use. For instance, it could provide subsidies to lower investors' risks during the early stages. To attract more investors, it could air frequent advertisements through the mass media to encourage the use of renewable energy.

As FiT is still quite new, the data collected on it remains limited. Thus, the public has a low awareness of the scheme. There should be further studies to examine the scheme after its coverage expands and sample sizes for study increase, so as to enable a more representative and comprehensive assessment of its feasibility.

WALKING TO THE TRAM: SPATIAL COGNITION OF THE TRAM ROUTE ENVIRONMENT IN HONG KONG

Undergraduate Category (PDD) - Second **Award**

Winner: TAM Hiu Lam

The University of Hong Kong – UPD

In cities, the interplay between their many moving and stationary elements is flexible, yet complicated, given the hardly predictable humanenvironment relations. Studies on spatial cognition have explored the psychological associations between travellers and their surrounding environments and sought to understand how the former acquire, mentally structure, and use geography to guide their travel behaviours. Travellers' cognitive maps represent their spatial knowledge and how they think, feel, and act in their surroundings. Thus, these maps perform as "coping mechanisms," which help people find places and how to get there.

Previous studies on cognitive maps focused on the general portrayal of certain neighbourhoods or cities. While some researchers drew connections between travel and spatial learning, there remains a limited understanding of how the existing transport infrastructure contributes to people's spatial cognition and various travel behaviours including route selection.

This study aims to fill this research gap by examining the relationships between the route environment and people's cognition map knowledge before they embark on their tram journeys. The study area is Sai Ying Pun, a largely residential area along the tram routes in Northwestern Hong Kong Island. The author conducted both street and online interviews and asked questions about respondents' tram use, spatial cognition, and sketching of cognitive maps. She then evaluated how the memories, impressions, and preferences of Sai Ying Pun's inhabitants entwined with the features of the tram route environment during their walks to the tram.

The result was that the respondents' spatial cognition along their tram routes was mainly shaped by street patterns and landmarks, the respondents' sense of direction, and their past experiences. Buildings, pedestrian roads, and crossings were the dominant features that helped the respondents learn and remember their routes. "Fuzzy" languages were frequently spoken to describe the physical distance and time required for the respondents' foot journeys, which were possibly induced by their time constraints. The simplicity and abstractness of sketched maps further suggested that the respondents' experiences and sense of direction, without attributive information, allowed them to reach their destinations. Incompleteness and distortions were believed to have been caused by confusion over streets with similar names, the low frequency of visits, and the habitual basis of the respondents' walks.

The limited awareness of the visual attractiveness and landscaped features hinted at a lack of character or liveliness in the respondents' spatial cognition. Even though many praised the clarity of Sai Ying Pun's street layout, they were also confused by some directions and locations including the tram stops. These aspects pointed at ways to improve the legibility and attractiveness of Hong Kong's tram routes and stops.

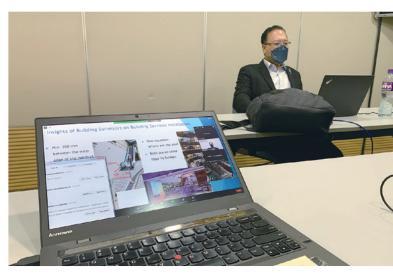

The revised Code of Practice is titled. Code of Practice, Land Survey Ordinance (Chapter 473). Fifth Edition - December 2021," and took effect on 3 December.

Mapping Evolution - the Services: the **Changing and Challenging Role of Authorised** Land Surveyors in a Smart City Era

Qualifications for registration as an Authorized Land Surveyors (ALS) - 認可土地測量師

According to the Land Survey Ordinance (Cap. 473), the applicant must be:

- •Member of MHKIS or equivalent
- •Minimum 1 year land boundary survey experience in Hong Kong acceptable to the Land Surveyors Registration Committee consisting of:
- (a) the Land Survey Authority as the Chairman;
- (b) 2 public officers from the Lands Department who have at least 5 years land boundary survey experience in Hong Kong and are nominated by the Authority;
- (c) 3 persons, not being public officers, who have at least 5 years land boundary survey experience in Hong Kong and are nominated by the Institute.

Recently there is a total of 27 Authorized Land Surveyors as shown on the List of Practicing Authorized Land Surveyors 2021.

By law, only authorised land surveyors (ALSs) registered under the Land Survey Ordinance can conduct land boundary surveys for subdividing private land in Hong Kong. At this seminar, Sr Dr Ken Ching reviewed the Land Survey Ordinance settings and the professional services that private practice ALSs can provide to multi-stakeholders. He also illustrated the changing and challenging role of ALSs during the smart city era through case studies. Ken concluded his presentation by sharing his views on how to handle the typical challenges young surveyors faced.

How to deal with the challenges?

To all young land surveyors, irrespective whether you are Authorized Land Surveyor or not:

- ✓ Should always try to improve and equip yourselves;
- ✓ Should venture into the areas beyond the scope of the traditional land surveying profession, e.g. get to know or even familiar about the laws of Hong Kong; about private contracts; and matters not merely related to land surveying but other professional services such as Heritage Studies; Urban and Regional Planning; Land Administration procedures; Traffic and Transport Studies; Artificial Intelligent and Social Economics.
- ✓ Should embrace and keep ourselves abreast of the ever-changing technological advancement such as Unmanned Aerial Vehicle (UAV); Airborne & LiDAR Survey; Mobile Mapping System (MMS); GNSS; GIS & BIM as well as 3-D Spatial Data Analysis. The development trends in these areas are extensive and could now be clearly seen.

Prop Tech: the Opportunity for Building Operation and Management

Reported by Vice Chairman Sr Jonathan Lee

Technology is a crucial strategy for improving the service standards and efficiency of property and facility managers. Recently, a new term, "prop tech," has become popular, particularly in the fight against the Covid-19 pandemic. A webinar titled, "Prop Tech – the Opportunity for Building Operation and Management," was held on 24 November to share the latest developments in this area. The featured speaker, Ir Andrew Young, is Associate Director (innovation) of the Sino Group and an expert

on the development and application of new technology.

The talk was very practical, comprehensive, and informative. At the first instance, digitalisation is the new normal and its implementation has been expedited in the past year with 5G wireless technology being widely applied to various industries. Different networks and systems could connect equipment and data systems to enable data exchanges at extremely high speeds. Robots were not only deployed to automatically disinfect a shopping arcade, but also provided one-stop customer services.

With the assistance of IT, big data and artificial intelligence could provide the optimum solution and configuration of operating central chiller plants to achieve maximum energy-savings.

Furthermore, Young briefed the audience on how the digital twins, BIM and drone applications, could enhance service quality and performance in building operations and management. During the Q&A session, there were enthusiastic exchanges on concerns over cyber security, long term running costs, etc. The webinar received plenty of positive comments and appreciation.

YSG delivered a career talk to over 80 Building and Real Estate Students (BRE) of the Hong Kong Polytechnic University at the Surveyors Learning Centre on 24 November. The students showed an interest in the surveying industry and their future careers. The ensuing small group sessions convened by YSG allowed the students to raise their concerns and learn more from its committee members.

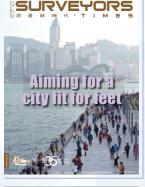

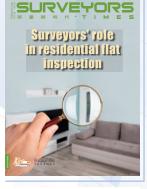
